## COMMENTS ON REVISED ATTACHMENT TO RESOLUTION 11-17

Staff requests substituting the revised project programming list for that initially distributed with the TPO/TAC/CAC agenda package. There are three types of revisions.

1. The revised Attachment includes several projects that were inadvertently left off the initial list.
2. The amount of funding or the mix between fund types changed on a few projects as the District proceeded to allocate all available funds. The Attachment now shows programming as of January 31, 2011, the date at which the Tentative Work Program is "locked down" and no additional changes are permitted.
3. One project receiving additional funding was the acquisition of right of way for the Parkway between the Palm Bay City limit and Ellis/I-95 (#9 in the Attachment). The total SU and ACSU funds programmed for the County segment increased to \$9.27 million. Based on discussion with FDOT, County and City staff, it is recommended that \$4.5 million of the \$9.27 million be reallocated from the County's segment to the City's segment (#10).

This action will provide sufficient funding to permit the construction of the entire Parkway section between Malabar and Emerson rather than just to Pace. The cost estimate for the Malabar to Emerson section including connector roads to the existing street system is \$11 million. The City has secured \$4.0 million in state grant funds and is also contributing \$2.5 million of City funds. The added \$4.5 million of SU fully funds the project. Design is complete, permits should be issued shortly and right-of-way has been acquired for this segment. The PD&E update is also nearly complete. The July 1, 2011 availability of the added federal funds works well with the City's time frame.

The Resolution Attachment includes the reallocation of funds as proposed above. Note also the stipulation that, in the event of low bids, any portion of the \$4.5 million SU funds not needed for construction of the Parkway from Malabar to Emerson (with connections at Pace and Emerson) would revert back to the County's Parkway project for continued use on right of way acquisition. This can be done by the TPO through a amendment to the Transportation Improvement Program.

The reallocation provides approximately equivalent TPO-controlled funding to the City and County Parkway projects.
